### SECTION V (First Aid Measures)

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink one or two glasses of water & induce vomiting by touching the back of throat with a finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.

IF ON SKIN OR CLOTHING: Remove contaminated clothing & wash before reuse. Wash affected areas with soap & warm water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

**SECTION VI (Spills or Leak Procedures)**

Absorb in saw dust or sand & dispose of properly.

**SECTION VII (Handling, Storage & Disposal)**

HANDLING: Wear rubber gloves. Wash hands after using.

STORAGE: Store in a cool dry area away from heat or open flame. Do not contaminate water, food or feed by storage or disposal.

DISPOSAL: Do not reuse container. Wrap container & discard in trash.

**SECTION VIII (Environmental Hazards)**

This product is toxic to fish & other aquatic animals. Keep out of lakes & streams. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment or disposal of wastes.

**SECTION IX (Precautionary Statements-Hazards to Humans & Domestic Animals)**

Humans: Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Prolonged or frequently repeated usage may cause allergic reactions in some individuals. Wash thoroughly with soap & water after handling. Remove contaminated clothing & wash before reuse.

Do not use on puppies under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant, medicated, or nursing animals.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, discontinue use & bathe ears with mild soap & rinse with large amounts of water. If signs continue, consult a veterinarian immediately.
